2017 Guidelines

1. **Applicant must be a member of a FFA Chapter or 4H/Extension program that is a paid subscriber of JudgingPro.com.**
2. Applicant must submit three (3) letters of recommendation. One letter should be from an FFA advisor or 4H/Extension leader. No letters from immediate family members. Letters should be included with the application.
3. Applicant must be a current high school junior or senior.
4. Applicant must have a high school counselor sign academic section.
5. Applicant must have FFA Advisor or 4H/Extension personnel sign FFA & 4H Information JudgingPro account section.
6. Applicant must demonstrate leadership and character.
7. Application **MUST** be typed.
8. JudgingPro staff will review applications and recipients will be notified by April 15, 2017.
9. Two scholarships will be awarded. Scholarships will be \$1,000 each.
10. Scholarships will be payable directly to the recipient by check.
11. **Applications must be mailed to the JudgingPro office and postmarked by March 1, 2017 to be considered.**
